2020 SWPBA Business Meeting Minutes November 19, 2020, Zoom Meeting

President Rebekah Taylor called meeting to order.

Roll Call:

AL=present, FL=present, GA=present, KY=present, MS=not present, NC=present, SC=present, TN=present; Eastern Band of Cherokee Indians and Poarch Band of Creek Indians attended 2020 SWPBA Conference, but were not present for the Business Meeting. Chris Decker (EPA) present as an observer only.

Ashley Lockwood summarized the minutes from the 2019 SWPBA Business Meeting.

Lara Panayotoff (KY) motioned to pass 2019 minutes. Justin Lewandowski (SC) seconded. **Motion passed unanimously.**

Minutes

Update

 Rebekah Taylor stated that at the end of the 2019 annual meeting there was \$3,197.08 in the SWPBA bank account. This year, \$131.19 was spent on the new SWPBA website, and \$64.99 was spent on the Zoom meeting, leaving \$3,000.09 currently in the SWPBA account. The website domain will need to be renewed in March 2022, and the webhosting will need to be renewed in March 2023.

Old Business

Proposal for SWPBA to Pursue 501c Non-profit Status

- Kim Laster (TN) proposed that SWPBA members reopen the discussion about filling out necessary paperwork for SWPBA to become a 501c non-profit organization. The motion was seconded by Lara Panayotoff (KY).
- Discussion: Kim Laster gave an updated PowerPoint presentation outlining the requirements to become a 501c non-profit organization because the proposed followup meeting to occur 30 days after the 2019 SWPBA Business meeting never took place. Because SWPBA brings in less than \$50,000 annually, it qualifies for a 1023 EZ form, which can be completed online. Kim proposed that the verbiage of the Constitution would not need to be changed because Article 6 establishes SWBPA as a non-profit organization already. The application requires a date and the signatures of at least two individuals on the organizing document, so Kim proposed the Bylaws be signed by the current and future president with today's date. This would allow SWPBA to acquire a EIN, which federal employees and vendors often need in order to attend the annual SWPBA meeting. Per Kim, it is getting harder and harder to do business without an EIN. The 501c application process also requires a name and address, a rough budget for the last 5 years, and a one-time fee of \$275. Kim volunteered to handle the application process. After that, SWPBA must file a 990N tax form each year. Kim volunteered to be responsible for this, or proposed that it could be the responsibility of the president each year.
- Mark Vander Borgh (NC) stated that he serves as treasurer of the Lake Management
 Society of North Carolina, and it is no big deal to complete this paperwork. He stated
 that it is not a daunting task. He also stated that passing the responsibility from state to

- state should also not be a problem because he did not have to provide any identification on behalf of the organization in order to complete the 990N tax form. He agreed that the EIN is very important because it gives SWPBA the ability to attract new people, and it is helpful in accepting donations.
- Lara Panayotoff (KY) asked if SWPBA would have to be incorporated with a state to
 meet the 501c requirements. Kim Laster stated that there is an option to be
 unincorporated. Lara asked if SWPBA would need to modify the Bylaws so that we
 could appoint a treasurer. Kim stated that the Bylaws state that we have to elect
 officers—it does not specify what they are. It should not be necessary since one of the
 two officers that currently serve usually handles the bank account.
- O Kim Laster (TN) proposed that this year's president and next year's president sign the Bylaws and date them using today's date to fulfill the 501c application requirements. It was decided that Rebekah Taylor would print the Bylaws, sign them, pass the document to the next president for the second signature, and then re-post the signed document on the SWPBA website so that Kim could access it. Kim stated that she will complete application process and create a tutorial for the 990N tax form so that future presidents have a guidance document to walk them through the process.

- Rebekah Taylor stated that in June-July 2020 when SWPBA officers decided that the 2020 annual meeting could not be conducted in person, Alabama made an agreement with Mississippi that Alabama would host the 2021 annual meeting in hopes that the meeting could be a traditional in-person meeting. No representatives from Mississippi were present in the business meeting to further discuss this option.
- Debbie Arnwine (TN) stated that the Bylaws do not state that you have to pass on the meeting to the next state, you just have to elect new officers.
- Lara Panayotoff (KY) suggested that we do a Roll Call through the list of hosting states, giving all other states the opportunity to decline hosting duties for 2021, so that the responsibility falls to Alabama again.

Proposed changes to SWPBA Constitution and By-Laws

1st Motion

1. Kim Laster (TN) proposed that SWPBA fill out the necessary paperwork to become a 501c non-profit organization. The motion was seconded by Debbie Arnwine (TN).

Discussion:

Kim Laster (TN) presented a PowerPoint which outlined what is required to file for 501c non-profit organization status in Tennessee. The process will not involve attorneys and is low cost. There is an EZ form for organizations that bring in less than \$50,000 annually. There is a \$275.00 one-time fee. There is an annual requirement to send in a 990 N form within three months of the end of the tax year. With the 501c non-profit status, SWPBA could apply online for an EIN number. The EIN number is often required by our members (federal employees) so that registration payments can be accepted. Currently SWPBA officers have to open a personal checking account to facilitate the meeting costs which can be a liability to those officers. Kim Laster offered to be the point of contact and to be responsible for filing the paperwork and 990 N form.

Mike Beiser (MS) raised concerns that there may be different requirements in each state and requested that the 501 c EZ form and related documentation be disseminated to the business meeting participants via e-mail for review. He suggested that we meet again after the members have had time to review the

documents and compare with the requirements in their respective states and that a conference call or electronic meeting be conducted for a vote on this matter. Other concerns are that the duties related to 501c non- profit status (e.g. filing the 990 N form, etc.) will need to be assigned to someone and the SWPBA bylaws will need to be changed to reflect that.

• 2nd Motion

2. Mike Beiser (MS) proposed that we delay a vote on Kim's motion in favor of a 30 day waiting period. Kim will send out the 501 c EZ form and related documentation to the business meeting participants via e-mail for review. After the members have had time to review the documents and compare with the requirements in their respective states. Within 30 days of this meeting, a conference call or electronic meeting will be conducted for a vote on Kim's motion to make SWPBA a 501c non-profit organization. This motion was seconded by Mark Vander Borgh (NC).

Roll call vote on 2nd Motion: Unanimous, the motion passed.

Chip Walton (TN) stated that he would contact all of the 2019 SWPBA meeting presenters to get permission to publish their presentations to the website.

SWPBA 2012 Business Meeting Minutes

- o Florida and South Carolina were not present at the business meeting
- As current hosting state, ADEM asked MS DEQ if they would accept hosting the 2013 SWPBA meeting
- o MS DEQ accepted
- Michelle Brossett of GA DNR nominated Emily Cotton as the 2013 SWPBA President.
 Cody Jones seconded the nomination.
 - o Emily Cotton was elected President.
- Cody Jones of GA DNR nominated Alicia Jacobs as the 2013 SWPBA Secretary. Michelle Brossett seconded the nomination.
 - o Alicia Jacobs was elected Secretary.
- o Emily Cotton listed Natchez or Olive Branch Mississippi as possible locations for next year's meeting.
- Lisa Huff of ADEM brought up the need to renew the SWPBA GoDaddy website account. She informed the meeting participants that Brandon Moody had volunteered to handle this, and asked permission to use SWPBA funds to pay this expense (\$117.50 for two years). SWPBA voted to continue to use GoDaddy for our website account and OKed the use of SWPBA funds for this purpose.
- Lisa Huff of ADEM brought up the problem that many states ran into with registration. More and more state and federal agencies would rather pay registration up front on a credit card, or using a purchase order, etc. But to use this method, they require a tax ID number, which SWPBA does not have.
- o James Worley: One problem with non-profit status is that it requires a permanent address. The Alabama Fisheries Association has gotten around this problem by using a P.O. Box. This has allowed them to use online registration through PayPal.
 - o It is also a problem that each year, an individual from the host state has to open a checking account to handle the funds for the meeting.
 - James Worley: Do we need a permanent bank account? Are there any bank chains that with branches throughout Region 4? Could just change names on account from year-to-year.
 - o Michelle Brossett: That would require that someone be in charge of the funds on a more full-time basis. Do we need a treasurer?
